**NOTICE IS HEREBY GIVEN** that Park Ward Neighbourhood Forum has submitted a draft Neighbourhood Development Plan (the “Park Ward Neighbourhood Plan”) to The Borough Council of Calderdale (“the Council”) under Regulation 15 of the Neighbourhood Planning (General) Regulations 2012 (as amended). The Plan sets out a vision for the future of the area and planning policies which will form part of the development plan used to determine planning applications locally.
